Research in northern VT has suggested that variety, as opposed to just day length, is important in determining corn yield. To this end, we have planted an array of corn varieties at multiple sites in the area to demonstrate whether and which short season corn varieties perform as well as longer season varieties. The objective is to test varieties on our soils and find optimum day length so that there is more time in the fall for cover crop seeding and establishment. We will also have the opportunity after lunch to look at other cover crop/no-till fields on the farm.
